DUE TO FUNDING PROVIDED BY THE FOUNDATION, SERVICES ARE FREE AND OPEN TO THE BROADER MILITARY AND VETERAN COMMUNITIES. NEW IN 2020 IS MOAA'S JOB BOARD THROUGH A PARTNERSHIP WITH INDEED.COM. THE JOB BOARD OFFERS MEMBERS OF THE MILITARY COMMUNITY A PORTAL TO CONNECT WITH VETERAN-READY EMPLOYERS. SINCE INITIAL LAUNCH IN LATE JULY, THE SITE HAS EXPERIENCED NEARLY 1,300 VISITS PER MONTH.
