Dear Mr. President:

The Military Coalition (TMC), representing more than 5.5 million current and former servicemembers, veterans, their families, and survivors would urge you to authorize the use of National Guard members under Title 32, U.S.C. §502(f) orders in response to the COVID-19 outbreak instead of the current use of “State Active Duty” (SAD) orders. As the primary uniformed military first responders to homeland emergencies such as the current crisis, National Guard Soldiers and Airmen deserve full federal support and benefits. We thank you for doing so with the National Guard troops for New York, California, and Washington and ask you to continue this for other states.

As of March 19, all 54 states and territories have declared emergencies in response to COVID-19 and more than 2,000 members of the National Guard across 27 states were activated by their individual governors. Reports indicate further spread of COVID-19 among the American people should result in more National Guard servicemembers being activated.

While SAD is an effective way to quickly mobilize the National Guard in absence of a federal emergency declaration, it is an inferior duty status given the lack of typical federal military support and benefits. Additionally, as these orders are 100% state funded, this financially discourages states from mobilizing critical National Guard assets. This will particularly hamper smaller states from mobilizing the number of troops required to provide essential services should the medical caseload increase as predicted. This will prove even more true if states are forced to divert funds to shore up hospitals when the demand spikes.

Title 32 orders would allow a governor to order National Guard servicemembers to full-time duty status under the command and control of the State, but their mission would be federally funded. Title 32 status would also provide Guardsmen with:

- TRICARE medical coverage
- Access to military hospital facilities
- Federal workman’s compensation
- Death gratuity
- GI Bill eligibility
- Service credit for military retirement

We are particularly concerned that should one of our young men or women contract the virus on duty responding to COVID-19, they will not have access to immediate military medical care. Under SAD orders, National Guard servicemembers not only do not have access to TRICARE but they are not granted access to Active Duty military treatment facilities. Currently, if a servicemember gets sick or injured it would be up to the state to put the servicemember in civilian health care under the state medical system, adding yet another burden to our over-extended state governments.

We advocate for the requirement that the Department of Defense establish a formal process for governors to request the activation of our National Guard under Title 32, United States Code, §502(f), in response to catastrophic disasters and national emergencies. We believe that this authority, in support of the current National Emergency, will ensure a more streamlined, effective, and responsive activation to operations that support our communities and citizens in combatting COVID-19.

We appreciate your consideration of this important issue and ask you to consider the use of Title 32 to respond to this national emergency.
