We, the undersigned veteran and military service organizations representing a collective membership of millions, express our gratitude for all the work you and your colleagues have done to respond to the global COVID-19 pandemic. Your diligence has made a difference by protecting those working on the front lines, ensuring needed healthcare is still obtainable, and sustaining millions of Americans whose lives have been seriously disrupted.

We know there is still more work to be done and stand ready to advise and support your efforts. We ask now that you help cover a small but deserving cohort, the children of veterans who are disabled or who died from a service-connected disability. This population does not have the healthcare coverage afforded to most Americans through private or federal healthcare policies. Dependents and survivors of veterans on the Civilian Health and Medical Program of the Department of Veterans Affairs (CHAMPVA) should not be left out due to disparate treatment.

Many of these children risk losing their healthcare through no fault of their own, as they may be unable to enroll or continue their college program resulting from the COVID-19 outbreak. Many others are among the 6.6 million who have lost their jobs or are unable to secure employment. Given the extreme magnitude of the crisis, we urgently request your support in passing the CHAMPVA Children's Care Protection Act. Please ensure this bill gets through committees and into the next national relief and recovery supplemental appropriations package in order to secure their health care and protect their well-being.

Given the immensity and unprecedented nature of the crisis, we thank you for your immediate attention to this pressing issue. We look forward to supporting you as you work to get the CHAMPVA Children's Care Protection Act included in the supplemental appropriations package so we can protect this vulnerable population.
